

2020 ANNUAL REPORT





It comes as no surprise that our community has been tested and transformed by COVID-19. This pandemic has forced Main Street Programs and downtown businesses to think far outside the box and change the way they do business in almost every conceivable way.

With support from local Main Street programs like ours, many local businesses have quickly changed to new business models and have spent the last several months continually changing that business model to both meet the needs of their customers as well as maintain state and federal guidelines to fight this virus and keep their doors open.

Beginning in March of this year, Guthrie Main Street's primary focus shifted to how best to assist our local businesses during this pandemic. When businesses slated "non-essential" were shut down, we purchased \$5,000 in gift cards from five local businesses. In April, Guthrie Main Street partnered with Guthrie Tourism, Novelis, and Koppers to create the Guthrie Main Street Disaster Relief program which was a grant to local small businesses forced to close or reduce services in response to COVID-19. This grant awarded \$12,000 in grant funding to local businesses in Guthrie. These grants were awarded to businesses in all of Guthrie – not just our downtown area.

In addition, Guthrie Main Street assisted local businesses in grant applications, PPP loans, unemployment guidance, and helping our businesses meet guidelines set by our Governor's office.

2021 may prove even more difficult. According to the National Main Street Network's recent study on the impact of COVID-19 on small businesses, as many as **7.5 small businesses nationwide are at risk** in the coming months, especially those that are employing fever than 20 people.

Now it is more important than ever to support your local business owners! Please join us in **shopping local in 2021** and helping them make 2021 a better year for them - and for our community!
